

## HAMILTON COUNTY SCHOOL DISTRICT 2016-2017 REGISTRATION INFORMATION

### Registration

District-Wide Registration for Dahlgren, East Side, Junior High, and High School students will be held at the Jr./Sr. High School. Following are the dates & times:

Wednesday, August 3 from 11:00 a.m. to 3:00 p.m.

Thursday, August 4 from 10:30 a.m. to 7:00 p.m.

Friday, August 5 from 8:30 a.m. to 11:30 a.m.

All Jr. High & Sr. High students **MUST** have a picture taken with Iconik Studio at registration. This also includes seniors unless they have had their picture taken by Iconik Studio this summer. This applies only to Junior High & Senior High students.

### School Fees

Parents are reminded that registration fees are due prior to the enrollment of their child in school, which also includes any fees still owed from the last school year.

- The Registration Fee for Kindergarten through 12<sup>th</sup> Grades is \$30.00.
- Students in Grades 5<sup>th</sup> through 12<sup>th</sup> will pay an additional \$3.00 fee for a student handbook.
- Students in Grades K through 12<sup>th</sup> will pay an additional \$20.00 technology fee.
- Students in grades 5<sup>th</sup> and 6<sup>th</sup> will be charged a \$10.00 athletic participation fee. This fee will be non-refundable after the season starts.
- Optional school insurance – various plans and rates.

- **Senior High Yearbooks** may be ordered at registration at a cost of \$35 or \$41 with a name stamp. Cash or check will be accepted. Checks should be made out to Pyramid Staff. You may reserve a copy for \$5 and make payments.
- \$6.00 fee for lock (optional at Senior High, but locks are required on P. E. lockers at the Jr. High).
- Students should be prepared to make a payment on their lunch account for school meals while registering.
- An athletic participation fee of \$40.00 per year for the first sport and \$20.00 for the second sport will be charged to 7<sup>th</sup> through 12<sup>th</sup> Grade students. This fee will be non-refundable after the season starts.

**Waiver of Fees** – You may be eligible for a waiver of student fees if your gross income is under that set out in the federal guidelines for free meals, or if you are otherwise able to establish that you cannot afford to pay these fees. If you think you may qualify for a fee waiver or free meals, please bring proof of income with you to registration (check stub, public assistance documentation, etc.) **Note: Rend Lake College Dual Credit classes & Driver's Education do not qualify for a fee waiver.**

## **Health Exam and Immunization Information**

Parents are reminded to bring the required health records when they register their children for school. Students entering kindergarten, 6<sup>th</sup>, and 9<sup>th</sup> grades are required to have a physical examination (including the parents signed health history section), and up-to-date immunization records (including completion of Hepatitis B series, a Tdap booster in 6<sup>th</sup> grade, and 2 doses of Varicella vaccine in 6<sup>th</sup> and 9<sup>th</sup> Grades). Also, students entering 6<sup>th</sup> Grade are now required to show proof of receiving 1 dose on or after 11<sup>th</sup> birthday of Meningococcal Conjugate. Students entering 12<sup>th</sup> grade are now required to show proof of receiving 2 doses of Meningococcal Conjugate vaccine. First dose on or after 11<sup>th</sup> birthday and 2<sup>nd</sup> dose on or after 16<sup>th</sup> birthday. If 1<sup>st</sup> dose is administered when student is 16 or older, only 1 dose is required. All the above requirements are to be completed by October 15. Dental exams are required during kindergarten, second, and sixth grades (to be completed sometime during the school year). An eye exam is also required before starting kindergarten. Exam forms are available from the office of any school.

Students in grades 5, 7, 8, 10, 11, and 12 trying out for sports/cheerleading activities, are required to have a sports physical examination (current within the last 395 days of the duration of the sport, not the starting date). Documentation must state that the student is able to participate in certain or all activities. The sixth grade and ninth grade school physicals will complete the sports requirement for those grades, so no additional sports physical is required.

## **New Students to the District**

- Any new student to the district for the first time must provide a certified birth certificate, a certified social security card, proof of a physical examination and eye examination, and up-to-date immunization records. They must also have a dental examination if they are entering kindergarten, second, or sixth grades (to be completed by May 15<sup>th</sup> of the current school year).
- Elementary students that were not in attendance at the end of last school year should call East Side School at 643-3323 or 643-2328, extension 6181, 6110, or 6118 to determine in which elementary school they should register. In order to balance classes, parents of these students should call by Monday, August 1.
- New High School students to the district that do not have a schedule already developed should call Mrs. Lueke in the guidance office at 643-2328, ext. 2116, to set up an appointment prior to August 7. New Jr. High students should contact Mrs. Fetcho at 643-2328, extension 2114.

## **General Information for the Start of School**

First day of attendance for K-12 students will be Tuesday, August 16, 2016. Buses will pick-up at their normal times and students will be released according to the following schedule. Dismissal times on August 16 will be East Side at 11:15; Jr./Sr. High at 11:25 and Dahlgren at 11:45.

School will also be on an early dismissal schedule from Wednesday, August 17 through Friday, August 26, 2016. Dismissal times are as follows:
